

Project Overview

Purpose: Traffic calming improvements to reduce vehicular speeds, improve pedestrian and bicyclist safety.

Project improvements: roadway widening and reconstruction, milling and resurfacing, drainage improvements, constructing a ten-foot shared-use path on the west side of the roadway and a six-foot sidewalk on the east side, driveway reconstruction, installation of new speed tables, bus shelters and pads, guardrail safety improvements, and pedestrian lighting infrastructure along the newly constructed sidewalks.

Construction Start Date: June 3, 2024

Completion Date: Summer 2026

Estimated Construction Cost: \$10 million

Scope of Work – Roadway and Pedestrian Improvements

Roadway Improvements

- Roadway widening and reconstruction
- Milling and paving the existing roadway
- Drainage Improvements
- Driveway reconstruction
- Guardrail Installation
- Installation of speed tables

Pedestrian Improvements

- Constructing a ten-foot shared-use path on the west side of the roadway
- Constructing a six-foot sidewalk on the east side of the roadway
- Constructing bus pads and installing bus shelters
- Installing lighting infrastructure along the newly constructed sidewalks

Construction Phases

Phase 1

- Drainage and Roadway improvements on SW 10 Avenue between Lindell Blvd and Linton Blvd - East Side
- Drainage and Roadway improvements on SW 10 Avenue between Lindell Blvd and Linton Blvd - West Side

Phase 2

- Drainage and Roadway improvements on Lindell Blvd West Side from SW 10th Avenue to Old Dixie Highway – West Side
- Drainage and Roadway improvements on Lindell Blvd West Side from SW 10th Avenue to Old Dixie Highway – East Side

Phase 3

Final milling and resurfacing operations, signing and pavement markings

Construction Working Hours

7:00 AM to 6:00 PM – Monday Through Friday

Lane Closures / Flagging Operations

- 9:00 AM to 3:00 PM Monday Through Friday
- During these times one thru lane will remain open though may be controlled with flagging operations.

Irrigation and Driveways

Advance Notice

- Residents are notified that construction is commencing on June 3, 2024.
- Residents will be notified in advance with door hangers of work near or in front of their homes.

During Construction


- Irrigation lines extending into the public right of way will be cut and capped. Residents wishing to make their own modifications may do so at any time in advance.
- Right-of-way stakes have been installed throughout the project corridor for homeowner reference (wood stake with orange flag). All plants, vegetation, and personal items in the public right of way should be removed by the property owner in advance.
- Driveway access impacted as part of construction will be restored daily by the Contractor.
- Additional notifications will be provided for driveway reconstruction and sidewalk installation operations.
